### ARTICLE I: ABOUT MOU

3. Industrial Internship is an important aspect of the various programs of the Don Bosco College of Engineering. The students of the institute will get exposure for industrial Internship which will be mutually beneficial for the students and organization.
4. To provide a platform where experts from the corporate and students come under one roof.
5. To ensure the visiting faculties from industry with relevant experience and expertise to share knowledge in the area with changing technological scenario.
6. To relate course curriculum with real life technological phenomenon.
7. To develop research and innovation ability among budding engineers/trainees.
8. To develop a concept of "train the trainers" so that trainers to get hands on knowledge of the emerging technologies.
9. To ensure entrepreneurship skills among willful candidates.

- SET the ground for longer-term Institute-Industry partnerships for Industrial Internships, Guest lectures and Skill Development.

3. The parties may enter into specific written agreement under the authority of this MOU to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues.

3. The activities of this MOU must be carried out in accordance with appropriate laws and regulations of the Institute and the industry.

#### **ARTICLE V: VALIDITY AND TERMINATION**

This MOU is valid for two years from the date of signing of this MOU. Thereafter the MOU may be renewed for such term and conditions as may be agreed between the intended parties.

Either party may terminate the MOU for cogent and logical reason, by giving to the other party 30 days' notice in writing.
